

# Kia's FR Dance / Fascinating Rhythm School of Performing Arts

## Rules and Conditions

### Financial Commitment

\_\_\_\_\_ **Initial** We assess a \$30 Registration Fee once per dance year. Once enrolled in class(es) you have committed instruction on a monthly basis. Monthly tuition becomes due the 1<sup>st</sup> of each month and is considered past due and subject to a \$15 late fee by the 15<sup>th</sup> of each month. We will only adjust the first month's tuition based on the start day, after which the tuition continues to be assessed on a monthly basis until the season ends or the student is withdrawn. (See Withdrawal)

For those who are not ready or able to make a commitment to regular class attendance, we offer a Drop-In option. Drop-In fees must be paid prior to attending the class. You will receive a "Golden Ticket" to present to the teacher of the class indicating that the class attendance is a Drop-In. Drop-in students are not enrolled and therefore not eligible for recital participation.

### Attendance and Make-Up Policy

\_\_\_\_\_ **Initial** Consistent class attendance is very important for mastering any skill. If a class is displaced for a holiday, teacher absence, studio-wide event, or weather, that missed class is eligible to be made-up in most age and level appropriate class **within 30 days of the event**. Please note: Aerial Silks and Tumbling classes are restricted as make-up classes to those enrolled Silks and Tumbling students, respectively.

To make up a class simply come to the office and request a "Golden Ticket" to present to the teacher of the class indicating that the class attendance is a Make-Up.

**We do not offer make-up classes or tuition reductions for personal absences.**

### Withdrawal

\_\_\_\_\_ **Initial** If you choose to leave a class or the studio for any reason, it is *imperative* that you contact the office (not the teacher). We provide an Add/Drop form to communicate any changes to your original enrollment. If you are unable to come to the studio to complete the form, an email request can document the withdrawal. Dropping classes or withdrawal from the studio is effective on the first of the following month. Please note: We do not prorate the monthly tuition for mid-month withdrawals. **Failure to formally withdraw from a class or classes will result in an additional month of tuition to be assessed.**

### Tuition & Payments

\_\_\_\_\_ **Initial** Tuition is due on the 1<sup>st</sup> of each month and is considered late after the 15<sup>th</sup> and subject to a \$15 late fee. For accounts that fall more than one month behind in payment, enrollment in classes will be suspended until the account is brought to a current status.

Payments in check, cash and most major credit cards are accepted, as well as Venmo. We also offer an automatic credit card payment process.

### Injury Waiver

\_\_\_\_\_ **Initial** Dance, Acro and Aerial Silks are physical activities and with that comes a varying degree of risk of injury. I willingly assume full responsibility for any and all risks that could occur as a result of participation in the classes offered. I have fully read and understand these risks and by being allowed to participate in these activities, use of the facility and equipment, in addition to the payment of any fees or charge, I for myself, my heirs and assigns, hereby waive, release and forever discharge Fascinating Rhythm, LLC, Kia Crader Saunders, and their officers, agents, employees, independent contractors, representatives, executors and all others from any and all responsibilities of liability from injuries or damages resulting from my or my child's participation in any activities, use of equipment, classes or machinery in the above mentioned activities.
