Rules and Conditions

Financial Commitment

_____ **Initial** We assess a \$30 Registration Fee once per dance year. Once enrolled in class(es) you have committed instruction on a monthly basis. Monthly tuition becomes due the 1st of each month and is considered past due and subject to a \$15 late fee by the 15th of each month. We will only adjust the first month's tuition based on the start day, after which the tuition continues to be assessed on a monthly basis until the season ends or the student is withdrawn. (See Withdrawal)

For those who are not ready or able to make a commitment to regular class attendance, we offer a Drop-In option. Drop-In fees must be paid prior to attending the class. You will receive a "Golden Ticket" to present to the teacher of the class indicating that the class attendance is a Drop-In. Drop-in students are not enrolled and therefore not eligible for recital participation.

Attendance

Consistent class attendance is very important for mastering any skill. If it is necessary to miss a class for illness, personal reason or scheduled holiday, you are able to make up the missed class in most age and level appropriate classes. You must make up the absence within one month of the absence or it is lost. Please note: Aerial Silks and Tumbling classes are restricted as make up classes to those enrolled Silks and Tumbling students, respectively.

To make up a class simply come to the office and request a "Golden Ticket" to present to the teacher of the class indicating that the class attendance is a Make-Up. If a class is cancelled for any reason, teacher absence, studio-wide event, etc., that class is eligible for make-up.

Withdrawal

_____ **Initial** If you choose to leave a class or the studio for any reason, it is imperative that you contact the office (not the teacher). We provide an Add/Drop form to communicate any changes to your original enrollment. If you are unable to come to the studio to complete the form, an email request can document the withdrawal. Dropping classes or withdrawal from the studio is effective on the first of the following month. Please note: We do not prorate the monthly tuition for mid-month withdrawals. **Failure to formally withdraw from a class or classes will result in an additional month of tuition to be assessed.**

Tuition & Payments

_____ **Initial** Tuition is due on the 1st of each month and is considered late after the 15th and subject to a \$15 late fee. For accounts that fall more than one month behind in payment, enrollment in classes will be suspended until the account is brought to a current status.

Payments in check, cash and most major credit cards are accepted. There is a 3% convenience fee for credit card payments. We also offer an automatic credit card payment process. It is also subject to the 3% convenience fee.
